




What Is A President?

Today, the President of the United States of America is the elected head of state and head of government. He is also commander-in-chief of the United States Armed Forces. The American president is considered to be one of the most powerful political figures in the world.



Where Does the President Live?

The official residence and work place is the White House in Washington, DC. Since 1800, every president has lived here.



How Do You Become The American President?

To become the American president today, you have to be a natural-born US citizen. You could be president if you were born in another country but both your parents were American citizens. You must also be at least 35 years old and have lived in the United States for at least 14 years, although this doesn't have to be consecutive years.

Most importantly, you have to be chosen by the people of America. Every four years there is an election. People vote for one of the candidates running for the presidency. After the election, the new president and vice-president take their oaths on 20th January.



Political Parties

The two main American political parties are the Democratic and Republican Parties.



The parties do the following:

- Select candidates to run for important positions in the US government.
- Keep American citizens informed about what is happening politically in their country, at a local and national level.
- Assist in making decisions about past, present and future rules and regulations (legislature) in the USA.
- Make sure that the political party currently in power (if not their own) is acting in the best interests of all American citizens.

Democratic Party – Their Values

Economy - All Americans should have the opportunity to succeed and all working families should enjoy economic security. This is achieved through job creation, rebuilding infrastructure and investing in small businesses.

Education - All American children should have access to a quality education that gives them the tools they need to lead a life of success and happiness. US schools must prepare the next generation for success in college and the workforce.

Energy - The USA must develop its production of renewable natural resources and become a more fuel-efficient nation in the hope that it can reduce its use of foreign oil.



Democratic Party – Their Values

Environment - The USA must take care of its ecosystems, invest in clean energy production and protect endangered species.

Equality - Every US citizen should be treated equally, on all fronts, regardless of race, religion, age and gender.


Health – All Americans should have access to quality, affordable healthcare.

Immigration - The USA should embrace the diversity upon which it was built and continue the tradition of innovation that immigrants have brought to the American economy. While protecting national security, a fair pathway to citizenship should be in place for those who wish to contribute to American society.



Democratic Party – Their Values

National Security - The US military should be able to respond to national and international threats facing the USA. American troops should have the training, equipment and support that they need when they are deployed. Veterans should receive the care that they, and their families, need when they return home.



Science and Technology - The USA should invest in technology and jobs of the future, and increase financial support for advanced research, labs and classrooms.


Republican Party – Their Values

Energy – The USA should become energy independent by investing in renewable energy programs in the USA. This would create more jobs to fuel the economy and lower energy prices for American citizens.

Immigration – The USA should have an immigration system that upholds the law, keeps borders secure and improves the economy.

National Security – The USA must have a strong military to keep the people and its borders safe.


Poverty – Americans should support their families by working hard. The best anti-poverty solution in the USA is helping American citizens find work.

George Washington (1789-1797)

On 30th April, 1789 in New York, George Washington took his oath of office as the first president of the United States of America.

George Washington facts:

- He was born in Virginia in 1732.
- Washington became a lieutenant colonel in 1754.
- He was elected commander-in-chief of the Continental Army in 1775.
- He died in 1799 and America mourned his death for months.

John Adams (1797-1801)



He was the elected vice-president to George Washington and then went onto become president in 1797. Born in 1735, he was a Harvard-educated lawyer. Harvard is one of the world's most prestigious universities. Adams worked in Holland and France in diplomatic roles and helped to bring peace to these countries.

He was the first president to live in the White House. On his second night there, he wrote to his wife...

'Before I end my letter, I pray Heaven to bestow the best of Blessings on this House and all that shall hereafter inhabit it. May none but honest and wise Men ever rule under this roof.'

He died in 1826.

Thomas Jefferson (1801-1809)

A strong believer in democracy, Jefferson was elected in 1801.

He was born in 1743 in Virginia. In 1776, he wrote the Declaration of Independence. This was a declaration written to King George III of England, which announced that America was no longer part of the British Empire.



A new nation was formed, known as the United States of America. Independence Day is celebrated each year in the United States on 4th July.

He died on the same day as John Adams, the previous president.

Martin Van Buren (1837-1841)

Shortly after his presidency began, there was a financial panic in America.

Born in 1782 in New York, his family came from the Netherlands. Van Buren was a lawyer who became involved in politics. In 1821, he was elected to the United States Senate. President Jackson gave him the role of Secretary of State. The Secretary of State is the president's chief foreign affairs adviser. He became Andrew Jackson's vice-president in 1832.



When he became president, the country was prosperous however three months into his presidency, hundreds of banks and businesses failed. Thousands of people lost land and for around five years, the country was hit by a depression. He died in 1862.

William Henry Harrison (1841)

In 1841, William Henry Harrison was the oldest president to be elected, until the election of Ronald Reagan in 1981.

After only 32 days as president, he became the first president to die in office. This is the shortest presidency in American history.

His vice-president, John Tyler, became president after his death.

Abraham Lincoln (1861-1865)

Lincoln was the president during the American Civil War. This was a war fought between states in the North and South of America. The Southern States didn't want to be part of the United States. Lincoln was with the northern states as they wanted to remain one country. During the Civil War, over 600,000 soldiers died and the Northern States won the conflict.



Abraham Lincoln facts:

- He was born in 1809.
- He was against slavery and a Republican.
- Lincoln was re-elected in 1864.
- In 1865, he was killed by a man, who believed Lincoln was helping the South.



- He is married to Hillary Clinton, who ran for the presidency in 2016.





